The Common Good Funds administered by the Council relate to the former burghs of Aberfeldy, Abernethy, Alyth, Auchterarder, Blairgowrie, Crieff, Kinross, Perth, and Pitlochry. Financial information for each Fund is summarised within the Council's Audited Annual Accounts, which are available at Perth & Kinross Council - Annual Accounts.

The annual income generated by each Common Good Fund may be distributed to provide community benefit or benefit to the inhabitants of the relevant common good area. Applications for financial assistance are considered by the Committee for each common good area. The Perth Common Good Fund Committee is the most active and the Committee meets five times per annum, usually in April, June, September, December, and February. Committee meetings for the other Common Good Funds are dependent on the timing and frequency of the common good business to be discussed.
